

Decision Expected in Appeal Against Wall Street Tycoon Steven A. Cohen

A decision is expected imminently in [Patricia Cohen v. Steven A. Cohen, et al.](#), the appeal we argued last year. We represent Patricia Cohen, former wife of Steven A. Cohen, principal of SAC Capital, one of the largest hedge funds on Wall Street.

The lawsuit alleges that Mr. Cohen hid millions of dollars of their marital assets during their divorce and perpetrated other RICO violations. The District Court dismissed the suit but we are optimistic

about our prospects for reversal in light of the February 2012 oral argument before a panel of the Second Circuit Court of Appeals in New York.

Oral Argument Granted in 11th Circuit Appeal Involving Daubert Motion

The Eleventh Circuit Court of Appeals will hold an oral argument in [Broussard v. Maples](#), where our experts' opinions were incorrectly excluded.

We hope the Eleventh Circuit will reinstate this RICO class action alleging wage depression by an Alabama rug manufacturer by hiring illegal aliens in order to depress the wages of American workers, our clients. The Eleventh Circuit allowed the landmark *Mohawk* class action to

proceed in a series of decisions from 2005-2009. However, those rulings did not address the important questions surrounding use of experts to establish which workers are illegal and the amount of wage depression caused by the RICO violations.

New RICO Allegations Against Oil Giant, BP

Foster P.C. is suing a U.S. subsidiary of BP for engaging in a years-long pattern of bribing Russian officials to effect sales of its petroleum products. This pattern of violating the Foreign Corrupt Practices Act, combined with the fraud committed against Lillian Borich of Chicago, establishes the basis for our RICO case. Discovery may uncover the extent to which BP has a bribery-based business model in Eastern Europe.

Hearing Set in \$100 Million RICO Suit

A hearing has been set in *Hourani v. Mirtchev*, the \$100 million suit brought on behalf of former Kazakhstan nationals who allege a conspiracy by a prominent Washington, D.C. consultant to extort their considerable business holdings.

The case is currently pending in the U.S. District Court in Washington, D.C.. This case has significant implications for other RICO cases which are based in the U.S., but have some foreign elements, a controversial issue in federal courts since the Supreme Court's 2010 decision limiting the reach of federal laws.
